The Scope of work would consist of having a Homeless Housing Staff person in Jackson County full time 5 days week, 40 hours. The individual would be responsible for taking all calls and visits from individuals who are homeless or about to be homeless. The staff person would also assist with the needs of the city. Responsibilities will be the following:

Transport to and from housing/mental health screenings

Persistently engage unsheltered in the City of Jackson

Field all calls and ability to handle face-face contacts

Attend Emergency Needs meeting and other meetings as needed

Address city concerns with person camping out

Research Grant possibilities for the Homeless

Conduct immediate intake and assessments for homeless individuals during outreach to determine eligibility, short term and long term housing and supportive service needs.

Provide basic screening referrals as applicable to alternate programs if the applicant is not eligible for internal programs and provide resources as necessary

Maintain contact and document interactions with all persons on an ongoing basis, Link to other programs, services and organizations as appropriate in conjunction to services.

Provide persons with hands on assistance to link with mental health services through the community mental health system. Assistance will include but is not limited to, making the phone call or visit for screening and eligibility with the person, providing follow up documentation, and continuing to communicate with assigned service providers to coordinate services.

Provide assistance to locate mainstream and community resources in obtaining benefits, birth certificates, social security cards and other important documents necessary for housing and supportive services Assist in efforts to secure housing for homeless persons by utilizing existing resources within the county. This will include but is not

limited to, assisting the person in filling out housing applications, locating mainstream resources to assist with security deposits and other housing assistance needs

Participate in community-based activities when appropriate such as Project Connect, PIT Count, and Human Services Fairs

More importantly, TTI would like to develop a one stop shop for Homeless individuals and/or families which would include Housing options (Permanent Housing, Transitional Housing, Domestic Violence Transitional Housing). Develop an affordable housing directory with lists of landlords and availability

and make connections with new and existing landlords. We would also assist the homeless with getting their benefits and apply for SSI/SSDI through the SOAR program which expedites the process.

TTI will ensure all activities are completed on a Monthly basis and tracked. SOAR initiatives will be completed within 30 days of initial contact for gathering information. There will monthly Landlord engagement activities.

The requested funds will assist with increasing Safe, affordable housing choices for the homeless population. The requested funds will assist with additional housing services for individuals that need assistance with obtaining benefits and maintaining their housing of choice.
